In the meantime, in substitution of the order under challenge, we pass the following interim order:

(i) No cable operator or T.V. Channel shall telecast any advertisement, which does not

conform to the law of the country and which offends the morality, decency and susceptibility of views or which is shocking, disgusting and revoking;

(ii)The telecast shall be monitored by the Election Commissioner of India;

(iii)The question as to whether the expenditure incurred by the candidate on inserting such advertisement should or should not be included, shall be considered on 5th April, 2004; and

(iv)The modalities whether such advertisements are in conformity with law, shall be laid down by the Election Commissioner of India.

Mr. S. Muralidhar, learned counsel, appears for the Election Commissioner. He prays for and is allowed three days time to obtain instructions.
